**RESOLUTION DESIGNATING LOCATION OF TEMPORARY COURT
FACILITIES TO BECOME EFFECTIVE JULY 30, 2019**

WHEREAS, the majestic but aged courthouse located at 125 Bridge Street, Marlin, Texas 76661 shall undergo extensive historic restoration beginning August 1, 2019; and,

WHEREAS, said restoration shall be completed more efficiently and cost effectively only upon complete vacancy of said premises; and,

WHEREAS, all Falls County governmental offices must continue to perform their essential functions so vital to the health and welfare of the citizenry during said renovation,

WHEREAS, these Falls County governmental offices and courts include, but are not limited to the following: the County Constitutional Court, County Clerk, 82nd Judicial District Court, District Clerk, 82nd Judicial District Juvenile Probation Office, Tax Assessor Collector's Office, Auditor's Office, Treasurer's Office, and Elections Office; and,

WHEREAS, the State offices of Agrilife Extension Agency, and the Texas Department of Public Safety office and Driver License Bureau will also be hosted at the temporary location; and,

WHEREAS, the Falls County Commissioner's Court has established, by order, a facility to temporarily house aforesaid offices, said facility being located at **1910 Industrial Park Road in Marlin, Texas 76661**


WHEREAS, it will be in the county's best interest to relocate all aforesaid offices to said location,

WHEREAS, the offices of the Falls County Community Supervision and Corrections Department, commonly known as the "Adult Probation Department" shall remain in their current location at the "Old Jail" building located on the Courthouse square;


NOW THEREFORE BE IT RESOLVED THAT, with the exception of the Falls County CSCD/Adult Probation Department, all of the above-referenced offices shall be conducting business of the county and the State of Texas forthwith at **1910 Industrial Park Road, Marlin, Texas 76661, said move being effective July 30, 2019:**

AND FURTHER all business lawfully conducted at the original Courthouse location shall thence forward be properly conducted at the temporary location, including, but not limited to: all terms of District and County Court, all meetings of the Commissioner's Court, all Sheriff's sales of foreclosed properties, and all postings of official public notices, **UNTIL FURTHER ORDER OF THIS COURT. IT IS SO ORDERED.**




Commissioner Precinct 1
