Judge Elliott asked for proof of posting and the same was affirmed by Elizabeth Perez, County Clerk, on the front door and also on the bulletin board.

#### Public comments.

A gentleman stood and wanted to thank Commissioner Wuebker and Road and Bridge for coming in and fixing the culvert on their road. He also wanted to state his concerns with the Solar Company wanting to come to Falls County.

### 3. Elected official reports.

Judge Elliott received an email from the National Association of Counties, and they are putting on an Online Leadership Program. Judge Elliott provided the information if anyone would like the opportunity to attend.

4. Discussion and/or action concerning courthouse renovation, and courthouse annex.
