Judge Elliott asked for proof of posting & the same was affirmed by Elizabeth Perez, County Clerk, on the front door & also on the bulletin board. Commissioner Nita Wuebker was not present for the meeting.

3. Elected official reports.

Judge Elliott gave information on the American Rescue Plan Information and Resources. Falls county was awarded a grant for \$3.3 million. The County will receive \$1.7 million in 2021 and \$1.7 million in 2022. The grant can be used for water, sewer and broadband, non-profit organizations, and small business loans.

4. Discussion and/or action concerning courthouse renovation, and courthouse annex.

Jim Hanks gave an update on the courthouse renovation. Everything is moving smoothly, and they are still on track. Flooring is going down on the 4th floor and they are working themselves down. The wood has been refinished in the district courtroom. Mr. Hanks is waiting on the quote for refinishing the chairs. Projected move in date is July 10, 2021.

Discussion and/or action concerning COVID-19.

The county is at 18 active cases. Judge Elliott made a motion to end the payment for Covid days, as of May 24, 2021. Commissioner Green seconded. Motion carried.

6. Discussion and/or action concerning hospital care opportunity.

Judge Elliott gave Notice of Closeout Grant. This means the grant is closed out. The grant money needs to be moved to the contingency fund. Commissioner Green made a motion to move the money from the grant to the contingency fund. Commissioner Albright seconded. Motion carried.

Commissioner Green made a motion to move forward with the payment of up to \$43,000 payable to the program. Commissioner Willberg seconded. Motion carried.

Jeff Jackson, road and bridge administrator, gave a report for road and bridge. The brush cutter operator will be out another 4 weeks. Trash day was this past weekend. They accepted tires and will hold them until the next tire day.
