COMMISSIONER'S COURT MINUTES FOR AUGUST 25, 2025

1. Proof of posting of notice in accordance with the provisions of Title 5, Chapter 551, Government Code (Vernon's Texas Codes Ann. 1994) as amended, known as the Texas Open Meetings Act.

The meeting was brought to order at 9:00 a.m. Judge Elliott asked for proof of posting that the same was affirmed by Elizabeth Perez, County Clerk, on the north and south door and the bulletin board.

2. Public comments.
