Judge Elliott asked for proof of posting and the same was affirmed by Elizabeth Perez, County Clerk, on the north and south door and the 2nd floor bulletin board.

Commissioner Albright stated that he wanted to know if NextLink had to fix the roads that they are messing up. Commissioner Wuebker stated that she had people asking why they have not received their tax statements yet.
