## EXHIBIT "A"

Description of: 0.34 acres, all of called Lot G and part of Lot H, Outlot 5 Northeast, City of Marlin, Falls County, Texas. Being an 0.34 acres tract situated in Outlot 5 Northeast, City of Marlin, Falls County, Texas, and being all of that called Lot G and part of that called Lot H described in the deed from Lott State Bank to James Lyons, et ux, recorded in Volume 181, Page 448, Official Records of Falls County, Texas, said 0.34 acres being more particularly described by metes and bounds as follows:

BEGINNING at a found 3/8" iron rod at the intersection or the North right of way line of Houghton Street and the West right of way line of Carter Street for the Southeast corner of said Lot G and this tract;

THENCE S 86°, 40' 39" W, 84.85 feet with the North line of said Houghton Street and the South line of said Lot G and Lot H to a found 5/8" iron rod in the South line of Lot H for Southwest corner of this tract and Southeast corner of the Leon D. Yezak tract.

THENCE N 4°, 40' 27" W, 173.76 feet to a set 1/2" iron rod in the North line of Lot H, for Northwest corner of this tract and Northeast corner of said Yezak tract;
