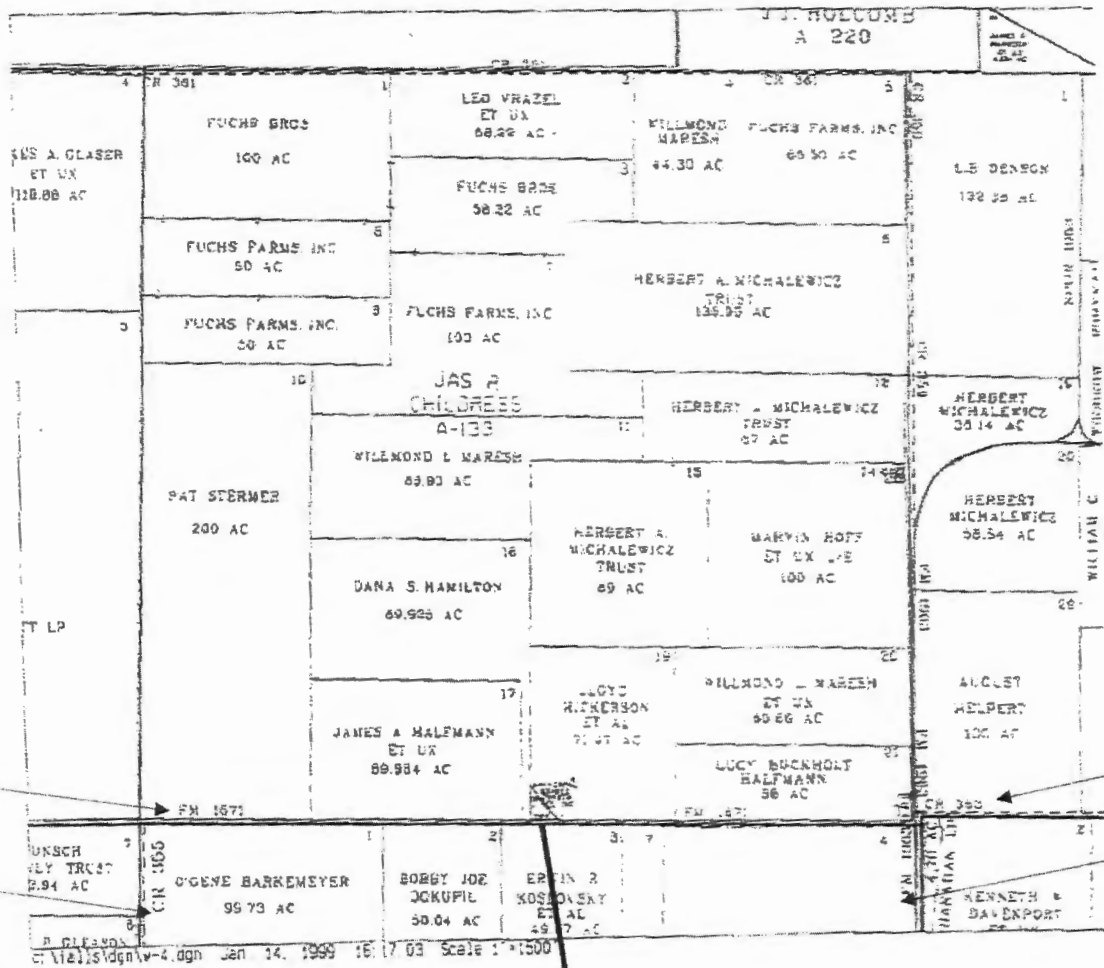


EXHIBIT "A" – RESALE LIST

Pursuant to Section 34.05(a)(c) and (d) of the Texas Property Tax Code, the properties listed below will be sold at a public resale of trust properties at the courthouse steps of the Courthouse in Marlin, Falls County, Texas, on **Tuesday, September 4, 2018**, beginning at 10:00 a.m. If not previously withdrawn from the resale, the presiding officer will sell the property to the highest bidder for cash or its equivalent. The bid will start at the amount of the minimum opening bid set out to the right of each tract, and no bid less than that amount will be accepted by the officer conducting the resale. **The purchaser will receive a tax resale deed, which is without warranty, expressed or implied.** It will be necessary that the bidders satisfy themselves concerning the location and condition of the property prior to the resale and to verify the status of all ownership interests and lien interests (including any outstanding municipal liens for cleaning and/or maintaining the property). Maps and plats of these properties and other instruments of title are on file in the office of the Marlin County Clerk in Marlin, Texas, and all papers in the underlying tax suit on which the resale is based are on file in the office of the Falls County District Clerk. 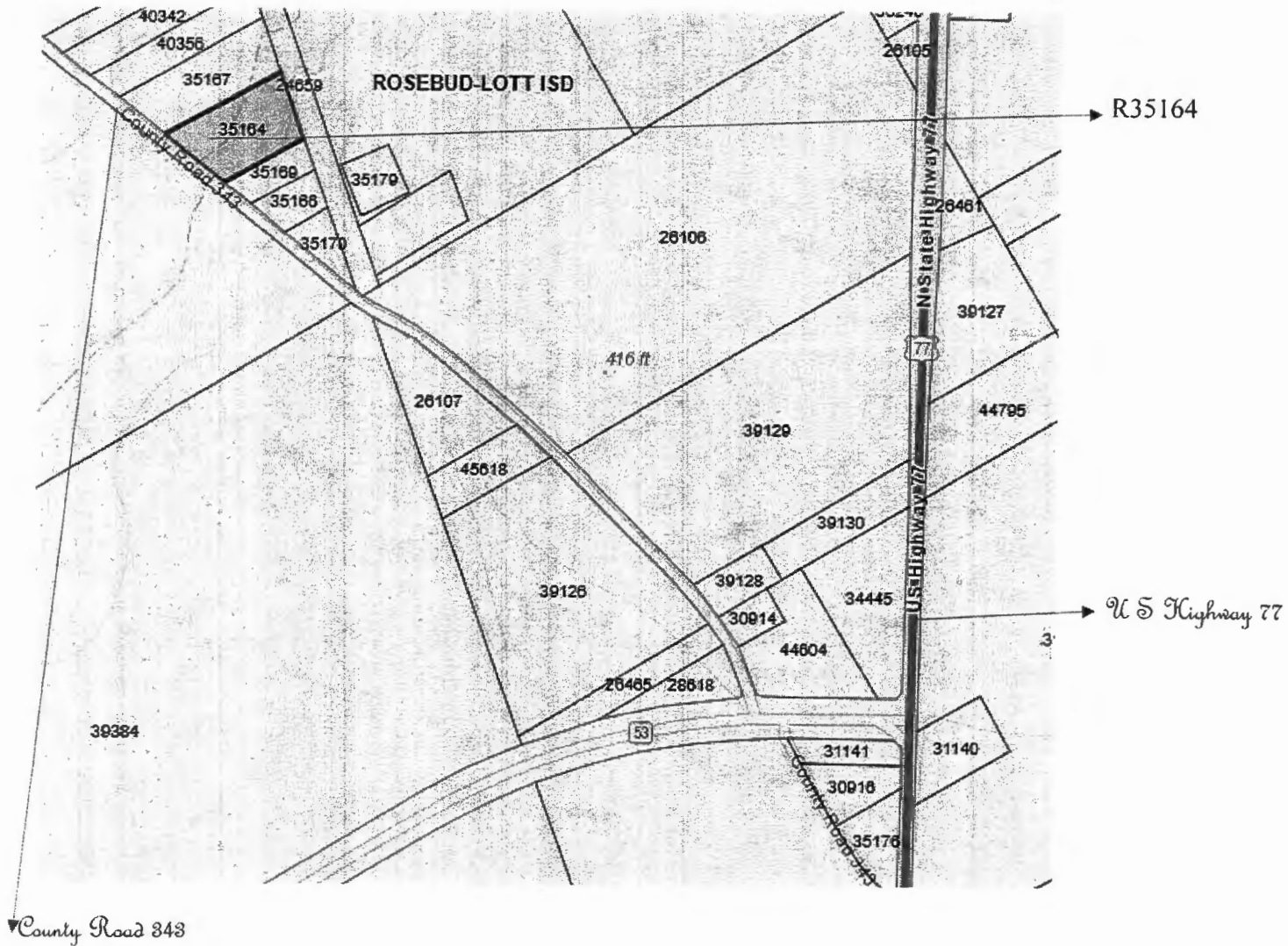
MAP 5 W Ave D Rosebud TX

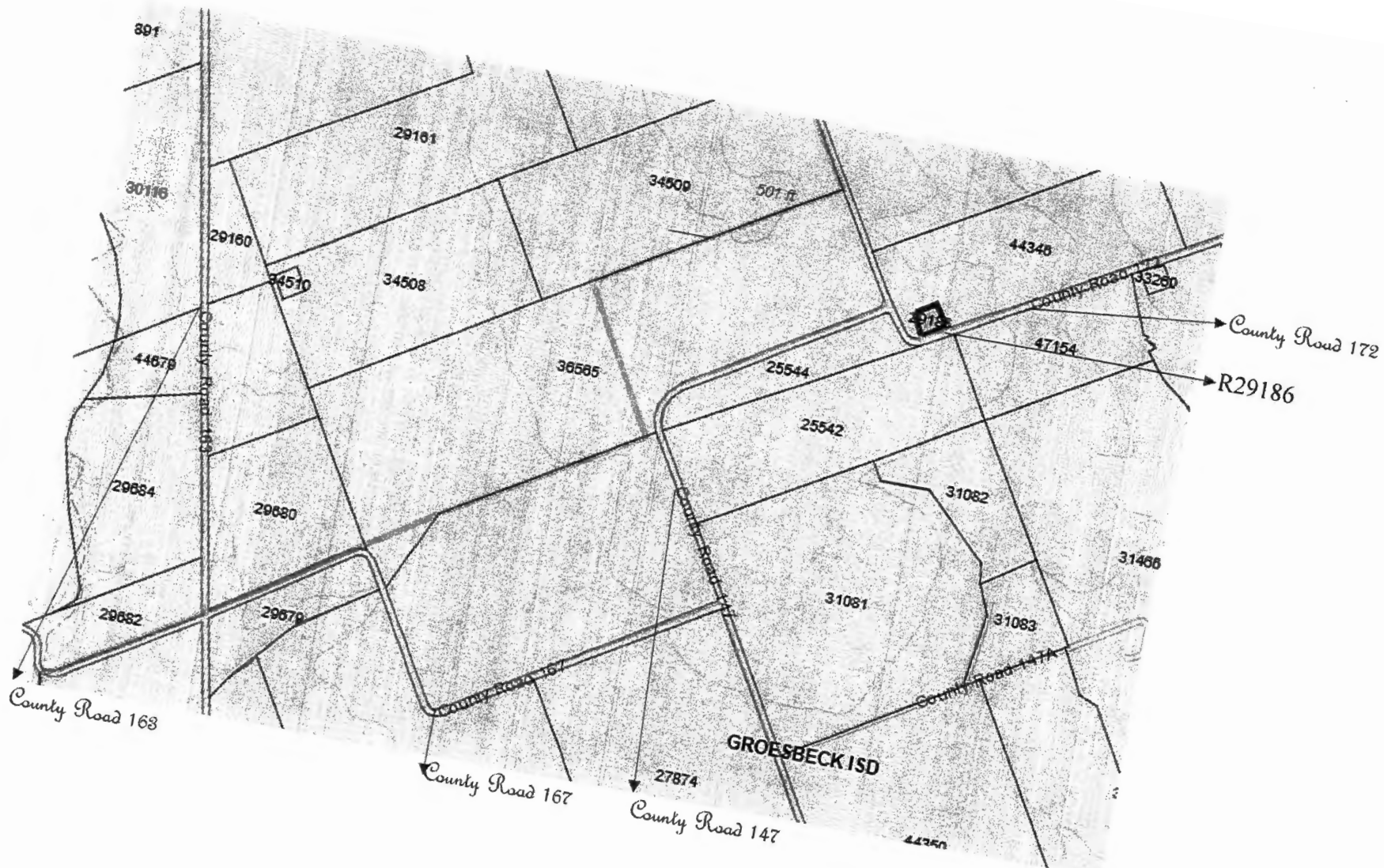
MAP 6 Mid Falls County TX

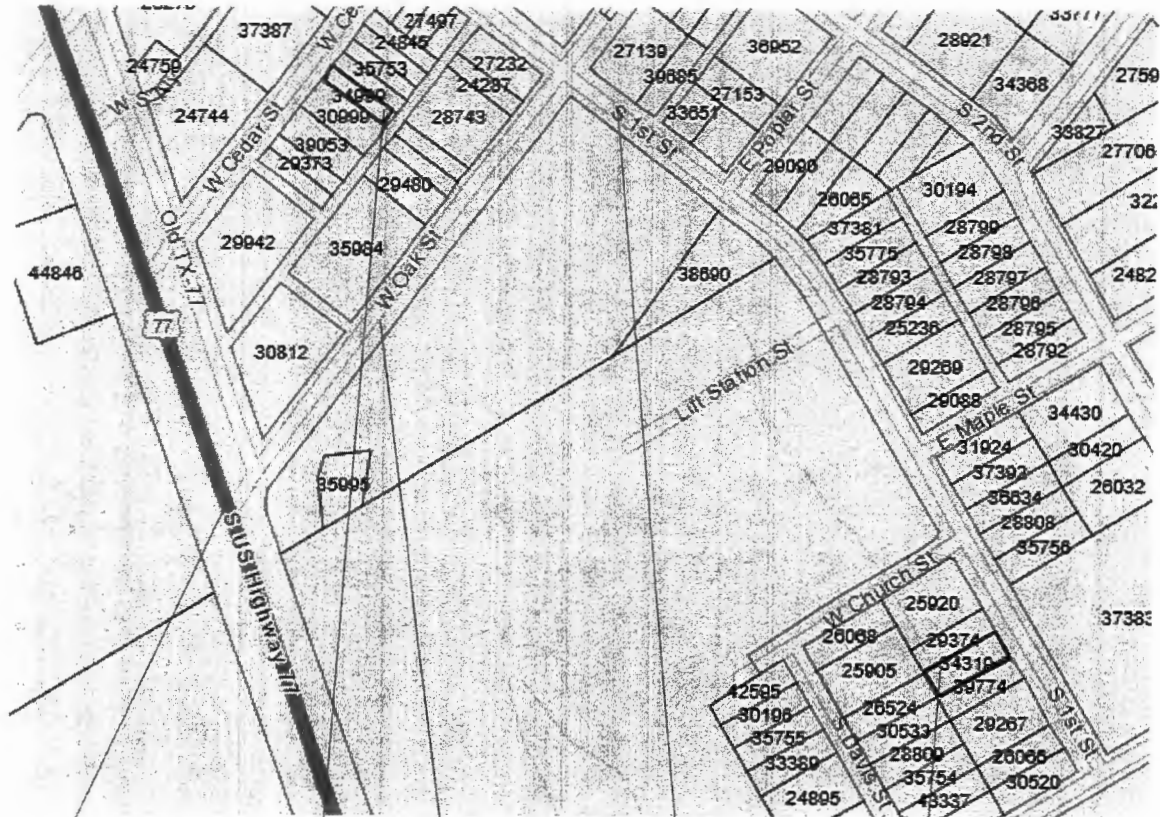
MAP 7 CR 343 NW Rosebud TX

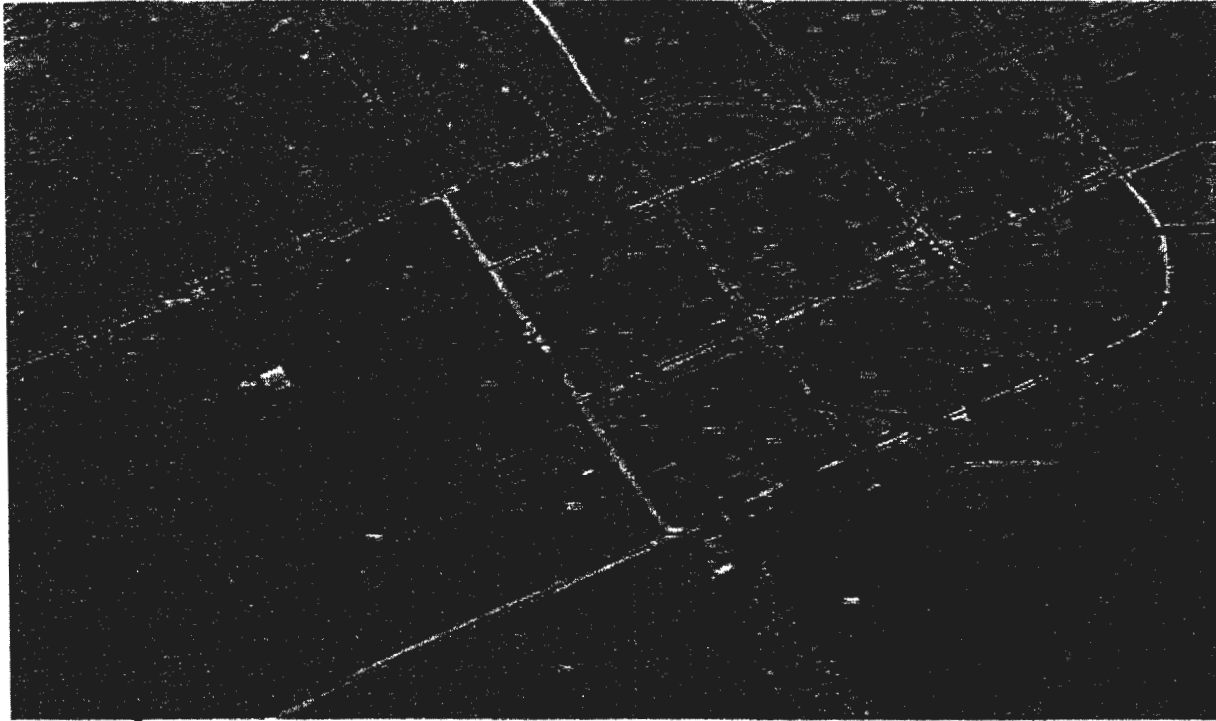

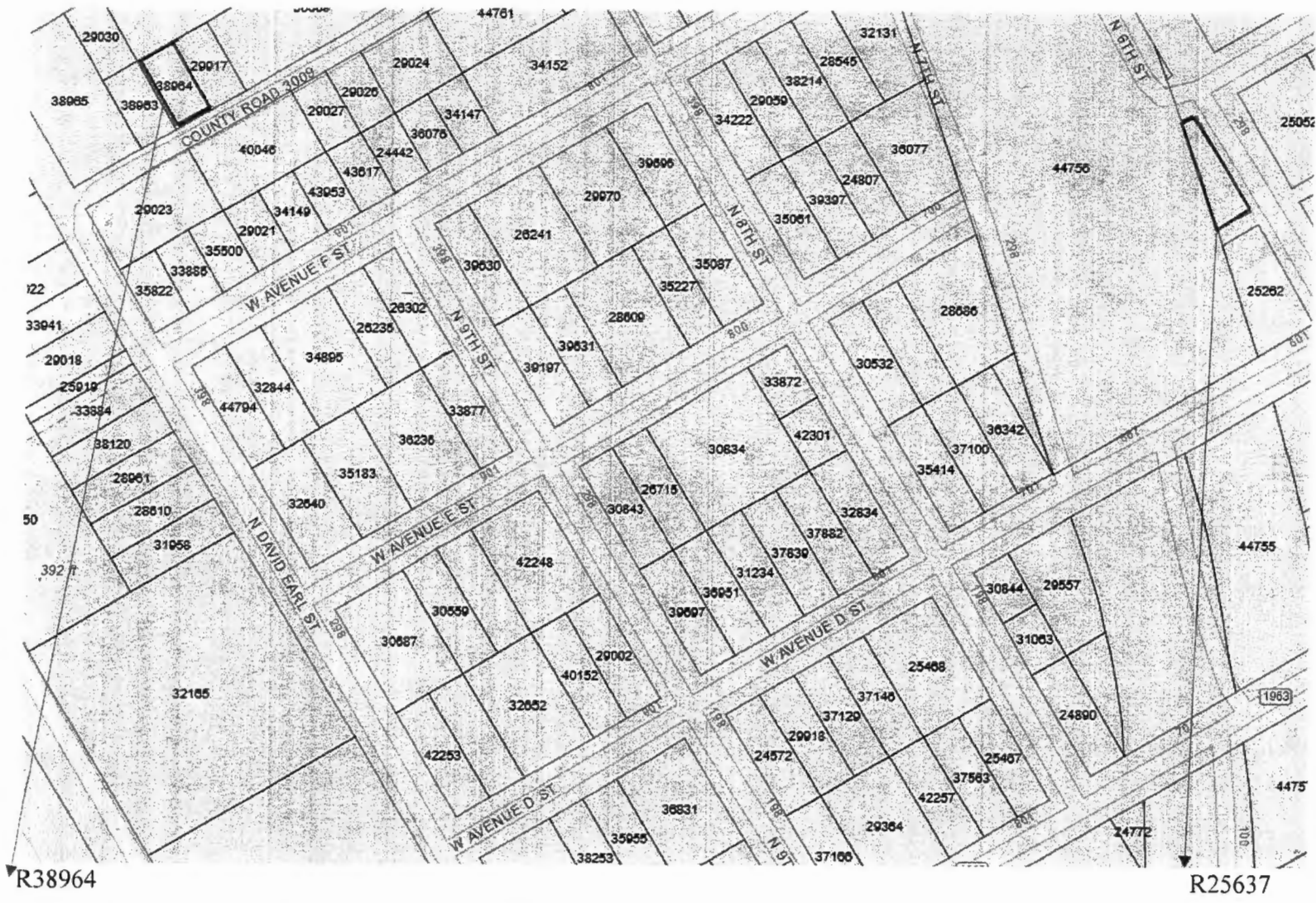
