DESCRIPTION AND MAP OF LORENZO ENERGY STORAGE REINVESTMENT ZONE

Lorenzo Energy Storage Reinvestment Zone is comprised of the following parcels. In the event of discrepancy between this Exhibit "A" and the attached map, the description shall control; provided however, the Lorenzo Energy Storage Reinvestment Zone shall in no way be deemed to include any portion of any municipality.
